NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. The 'Authors' hereby create a trust called "CHETANA CHARITABLE TRUST" which is created with an object of charitable purposes, ends and objects' here in after set forth:
2. The registered Head Offices of the Trust shall be situated at Door No. 2-14-137, Syamalanagar, 3rd line, Guntur, Andhra Pradesh, India or any other place as may be decided upon by the Board of trustees from time to time;
3. The objects of the Trust shall be the following: -
 - a) To promote, encourage, diffuse and aid the social cultural and educational interests of all women and children, irrespective of caste, religion etc.,
 - b) To establish, run, develop, improve and maintain "Multipurpose" rural schools offering security to the women, children, guidance to the young and solace to the old. Institutions training centers such as Vocational Training Centers, Orphanages, Hostel, Music halls, homes for aged, special schools for the handicapped persons and other institutions for the Benefit of the women, children and the aged at chowdavaram rural area or any other rural areas.
 - c) To establish branches and affiliate or amalgamate other institutions which have the similar objects to widen the activities.
 - d) To act as a Trust Board to accept endowments, bequests, donations, subscriptions, grants from institutions, both private and public, corporate bodies, and Government aid made to the Trust and administer them on the terms agreed to;
 - e) To carry on activities for any other charitable purposes and activities of General Public Utility and human welfare;
 - f) The above objects are independent of each other;
 - g) The activities of the Trust will not be carried out anywhere outside India.

5. To carry out the aforesaid objects, the Trustees are hereby authorised and empowered.
 - a) To raise necessary funds to maintain the educational institutions and other service Institutions for the benefit of women, children and the aged.
 - b) To make the objects of the Institutions popular among the classes and masses by any media;
 - c) To collect funds through donations, subscriptions or by such other sources as may be deemed expedient, for running the Institutions established by the Trust.
 - d) To amalgamate or affiliate any other Institution whose objects and interests may, in any manner directly or indirectly be substantially identical with the object or interests of the trust;
 - e) To acquire, purchase or sell any or all movable or immovable properties; to acquire by purchase or other-wise any rights or privileges including rights in immovable properties;
 - f) To invest and deal with all the moneys of the trust upon such securities and in such manner as may from time to time be determined by the trust;

- g) To pay either in cash or otherwise for any property or rights acquired and services rendered to the trust;
- h) To borrow, guarantee, raise or otherwise procure money in the security of movable, immovable or other assets of the trust or otherwise for carrying on all or any of the subjects of the trust at the discretion of the Trust Board.
- i) To do all or any of the above things, transactions or matters either alone or in conjunction with others either by or through servants, employees, or otherwise and to do all such other things as are incidental or conducive to the attainment of the above objects or any of them;
6. i) The First Trustees of the Trust shall be
 1. Dr. (Miss) Nannapaneni Manga Devi
 2. Sri Paladugu Lakshmana Rao
 3. Miss Desiraju Jayasri
- ii) The number of Trustees of the Trust shall at any time be not less than three and not more than five.
7. Any vacancy amongst the aforementioned First Trustees because of death or otherwise shall be filled only as per nominations obtained in writing from the said First Trustees during their life time. Such nominated trustees however shall not have a right of nominating their successors and any vacancy amongst such nominated trustees shall be filled in as per the provisions of paragraph 10.
8. All the Trustees who act as trustees under the terms of this instrument from time to time shall be referred to collectively as the Board.
9. The aforesaid First Trustees and their immediate successors as mentioned in para 7 shall hold such office for their life time or until they resign;

10. The Board may from time to time appoint one or more persons whom it considers to be interested in promoting the objects of the Trust to be Trustees of the Trust within the maximum number provided in clause No.6 (ii) hereof;
11. Any of the Trustees of the Trust other than the first trustees or their immediate successors shall hold office of a trustee of the trust for a period of Three Years from the date of his/her appointment. Such trustee could be reappointed by the Board under para 10.
12. Any vacancy caused in the office of a Trustee other than the First Trustees shall be filled in by the Board by appointing any person whom it considers to be interested in promoting the objects of the trust, who shall hold such office for a period of 3 years.
13. No person shall hold or continue to hold office of, or be appointed as a trustee.
 - a) If he is found to be or becomes a person of unsound mind:
 - b) If he is convicted of an offence involving moral turpitude :
 - c) if he is adjudged insolvent :
 - d) if he is, in the opinion of the majority of his co-trustees after due enquiry by them, found guilty of breach of trust, gross neglect or dereliction of duty :
 - e) if he is otherwise disqualified to act as a trustee according to law for the time being in force and governing charitable trusts.
 - f) If he accepts any loan from or becomes indebted to the trust, either directly or through another person or persons.
 - g) If he claims any right in any property belonging or claimed to belong to the trust as a trust property:
 - h) If he disclaims his trusteeship or is, or desires to be discharged from the trust or refuses to act as a trustee.

- 14) There shall be the following office bearers of the trust namely:
 - i) Chairman
 - ii) Secretary and treasure
- 15) Sri paladugu lakshman Rao shall be the first chairman of the trust and Dr.(Miss)Nannapaneni Manga devi shall be the secretary and treasure of the Trust.
- 16) Any vacancy in the offices of the chairman or any office bearer shall be filled from time to time as may be decided by the Board;
17. The Chairman of the Board shall, preside over all the meetings of the trustees;
18. If the Chairman is not present within half an hour of the time for which the meeting has been convened, the trustees present shall elect one of the trustees present at the meeting to be the chairman of the meeting;
19. The administration, direction and management of the institutions and establishments in terms of the trust hereby created shall, subject to the supervision, control and direction of the Board, be with the chairman. The Board may delegate specific duties of any kind to a trustee other than the chairman.
20. The Secretary and Treasurer of the Trust shall arrange for the maintenance of correct and proper accounts, of the receipts and disbursements and of the liabilities incurred and of the assets acquired, and for an audit every year of the accounts of the trust and of the income and expenditure relating thereto.
21. The Board shall cause the books of account of the trust to be closed once in every year by 31st March and an income and expenditure account for the year ending 31 St. March of every year and a statement of affairs as on that date to be prepared within six months from the close of accounting year.

22. The Board shall appoint a Chartered accountant to audit the accounts of the trust for every year and the chartered accountant shall make a report to the Board on the accounts examined by him.
23. The funds and properties of the trust shall be the said sum of Rs.10,000/- and all and every other moneys and properties gifted, conveyed, to be conveyed and transferred to the Board for the purpose of carrying out the objects of the trust hereby created and all or any income derived from the said sum of Rs. 10,000/- and additions and augmentations to the aforesaid sum.
24. The Trustees may apply the funds of the trust for any of the objects of the trust either by the trust itself establishing, running or maintaining institutions or other-wise or by making donations or contributions to other trusts or institutions for carrying out any of the above mentioned objects. The funds of the trust shall be invested or deposited in the forms or modes prescribed under sub-section 5 of Section 11 of the Income Tax Act, 1961 as amended from time to time. The funds and income of the Trust will be solely utilised towards the objects and no position of it will be used for payments to the Trustees by way of profits.
25. If, in the opinion of the Board, any property belonging to the trust is deteriorating in value or is not yielding a reasonable income, or its sale or conversion into property of another kind would be advantageous to the trust, the Board may exchange the same for property of another kind or sell the property and invest the proceeds in other movable and immovable property.

26. The Board shall have power to open one or more bank accounts for the Trust in its name with any Nationalised Bank or Banks as the trustees may deem fit and deposit monies of the trust in such accounts and to give instructions to the Bankers as to the persons entitled to operate such accounts. There shall at all times be two persons amongst the trustees who shall be authorised to operate such bank accounts.
27. The Board may give such directions to the Chairman, Secretary and Treasurer in relation to the affairs of the trust, as they may deem fit from time to time.
28. Until otherwise resolved by the Board, the Chairman shall, subject to the supervision and control of the Board, exercise all powers which are hereby vested in the Board except those which are by these presents expressly required to be done by the Board. Subject as aforesaid the Chairman and the Secretary shall be in control and possession of all properties, funds, money, books, accounts, papers documents of the trust and shall control the day to day affairs and administration of the trust and all dealings and actions thereof and shall have full control over all the employees and servants of the trust and take such action, disciplinary or otherwise, as may be necessary.
29. The Board shall meet at least twice in a year. The quorum for meeting of the Board shall be three.
30. The Board may act by a majority vote.

31. Any resolution in writing circulated to all trustees holding office for the time being as such and agreed to in writing by a majority of them on circulation shall be a valid resolution of the Board as if it has been done at a regular meeting at which they are present. The Chairman shall have, in the event of an equal division, a casting vote in addition to his vote as a Trustee. All acts done by a resolution of the majority of the trustee shall be valid and binding as if agreed to and done by all the trustees.
 32. The trust hereby created is irrevocable. The trustees may from time to time make and prescribe additional rules and by laws without detriment to the objects of the trust in such manner as they deem fit after obtaining the prior approval of the Commissioner of Income Tax having jurisdiction over the trust.
 33. If at any time the objects of the trust should become impossible of fulfillment or in case of dissolution or winding up of the trust, for any reason whatsoever, the funds and the properties of the trust shall be transferred to any other institutions having similar objects and registered with the Commissioner of Income Tax under Section 12 A of the Income Tax Act, 1961.
 34. This deed of Trust Created hereby shall take effect immediately.
